The goods and services shown below are those we can provide to members of Missouri Cremation Services and any licensed funeral establishment. You may choose the items you desire. However, any funeral arrangements selected will include a charge for our basic services and overhead. If legal or other requirements mean that you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include the price for certain items you may ask us to buy for you, such as cemetery services, flowers and newspaper notices. The prices for those items will be shown on your bill or the statement describing the goods and services you selected.

**Missouri Cremation Services Membership \$45.00**

Through simple membership, your instructions are kept on file with biographical information required for filing a death certificate and carrying out your wishes as you have instructed. You may change any instructions you wish during your lifetime, by contacting Missouri Cremation Services. This is a one time, non-refundable fee to become a member of Missouri Cremation Services. You must be a member to receive the Society Member's price.

## Itemized List of Items Included in the Direct Cremation Plan

### Basic Service of Staff

**Society Members \$745.00**

Our charge for basic services includes, but is not limited to, the services of our staff to respond to initial requests for service; the services of our staff for an arrangement conference with the family or responsible party; arrangement of the cremation services and filing of necessary authorizations and permits; minimum cremation container; recording vital statistics; preparation and placement of death notices. If you desire more personalized obituary information additional charges may apply based upon the newspapers of your choice.

### Travel Protection

**Society Members: Included**

If the death of a Beneficiary covered for cremation services under this Agreement occurs beyond the normal service radius of the Seller, the Seller will provide cremation services at or near the place of death for no additional expense PROVIDING, that seller is the first and only service provider to be notified of the Beneficiary's death, thus, eliminating unnecessary duplicated charges to the seller and/or Beneficiaries representative. Any costs for additional services not originally contracted for must be borne by Beneficiary or Beneficiary's representative.

### Bereavement Travel Program

**Society Members: Included**

As a membership benefit, four members of the immediate family of the deceased are eligible to receive special savings on airfares offered through the Bereavement Travel Program to travel to attend a funeral, memorial or graveside service. Additional details are available.

### A Proportionate Share of Overhead Costs

**\$275.00**

Included in this charge are the overhead expenses for operating the cremation facility such as responding 24 hours a day to calls, accounting and billing, secretarial and administrative costs, maintenance and utility expenses, equipment and inventory expenses, insurance expenses and similar overhead expenses.)

## Additional Cremation Service Options

The following selections are for services and merchandise that are also available.

### Refrigeration

The Society provides refrigeration for up to 48 hours at no additional charge. There is a \$95.00 per day charge after 48 hours.

### Witnesses Cremation

**\$150.00**

Family and friends may witness the placing of the body into the cremation chamber during a scheduled viewing at Horizon Cremation center.

### Embalming

**\$795.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### Other Preparation of the Body

cosmetology, dressing, and placement of the deceased in the casket and/or sanitary care for cremation.

### Holding of Cremated Remains

We will hold the cremated remains at no charge until arrangements are made for their release to the family at our facility during regular business hours. Cremated remains left over 60 days are subject to a monthly holding fee of \$50.00. If the recipient does not pick up the cremated remains within the 60-day period, Horizon Cremation Center and its affiliates shall have no responsibility for the cremated remains and may dispose of the said cremated remains in any lawful manner.

### Careful Packaging and Shipment of Cremated Remains

**\$ 50.00**

Cremated remains may be shipped through the U.S. Postal Service, return receipt requested and insured, to any domestic destination. The typical return time through this option is ten days.

### Priority Delivery through U.S. Postal Service (Two-Day Delivery)

**\$ 75.00**

Cremated remains may be shipped through the U.S. Postal Service, return receipt requested and insured, to any domestic destination. Two-day delivery is guaranteed by the U.S. Postal Service.

### Personal Delivery of Cremated Remains

**\$125.00**

One of our associates will hand-deliver the cremated remains to their destination at the date and time agreed upon.

### Sea Scattering or Sea Burial

**\$395.00**

We will arrange to have the cremated remains scattered or buried at sea through one of our affiliates. The scattering or burial is performed in accordance with all state and federal guidelines.

## FREQUENTLY ASKED QUESTIONS

### Why Should We Assist You With The Memorial Service?

We aspire to facilitate a memorial ceremony that reflects dignity and beauty. The survivors usually have so many things to cope with that our presence removes what could otherwise be a large burden to organize and oversee something so important. Our professional funeral service staff will receive flowers and deliver them to the memorial service location. We will prepare a typed summary for clergy listing the various details that pertain to the deceased and survivors as well as the ceremony. We will deliver, display or otherwise care for the cremated remains as you desire. We will reserve and assist with seating. We will provide memorial registers for signatures, greet your guests as they arrive and guide them as needed and distribute any printed materials as you wish. We will assist in displaying memory boards, photographs and mementos as you request. We will coordinate with musicians and clergy and prepare honorarium checks for these parties. We will deliver any flowers, photos or the cremated remains to the location of your choice. We will attend to any other specific needs you may have related to the service. We do all of these things to relieve you of attending to the details of the ceremony and be with your family and friends.

### What does "a proportionate share of overhead costs" mean?

You may have noticed on our general price list a charge for "A proportionate share of overhead costs". This charge represents the costs that our firm incurs to provide the following types of services for our families: the overhead expenses for operating the cremation facility such as responding 24 hours a day to calls, accounting and billing, secretarial and administrative costs, maintenance and utility expenses, equipment and inventory expenses, insurance expenses and similar overhead expenses.

Many firms add these types of charges into other items. We have chosen to separate these expenses often called, "fixed expenses" in order to track these items closely and do our best to control these costs for our families.
